## PITTSBURG STATE UNIVERSITY 2025 SCHOLARSHIP APPLICATION

The Construction Safety Group of Kansas City was organized in 1991 by a group of pioneering safety professionals who wanted to improve construction safety in the Kansas City Metropolitan Area. The group is sponsored by The Builders' Association, and made up of professionals from the construction industry, contractor trade associations, insurance industry, governmental agencies, and suppliers. To enhance the construction safety profession, The Construction Safety Group of Kansas City has established a non-profit fund to support scholarships, high impact research, and educational safety and health programs for the commercial construction industry.

The number of scholarships awarded is based on the number of qualified candidates and will be in the amount of up to **\$2,500 per student.** Scholarships will be awarded on a year-to-year basis. Applicants will be eligible to apply for up to four years of undergraduate study in Safety Management, Occupational Safety and Health, and/or Industrial Hygiene. Applicants with an emphasis in construction safety and health are highly desired, but not mandatory. Students pursuing a graduate degree program in one (1) or more of these disciplines are not eligible to apply. All applications will be reviewed and winners will be selected based on an applicant's financial need, interest in construction safety, grades, extracurricular activities, adult evaluations, and interviews.

## **1.0 APPLICATION REQUIREMENTS**

To be considered for the Construction Safety Group of Kansas City Scholarship Program all applicants shall:

- 1. Have a minimum 2.75 cumulative grade point average (GPA) upon submission of application.
- 2. Submit official college or university transcripts of your academic records.
- 3. Provide a minimum of two (2) letters of recommendations from two (2) separate adult, non-family members who are familiar with your academic or professionally related experience.
- 4. Complete the application form provided with this announcement.
- 5. Be a full-time student and have declared major in Occupational Safety. Applicants with an emphasis in construction safety and health are highly desired, but not mandatory.
- 6. Not be discriminated against, based on race, color, religion, age, gender, national or ethnic origin.
